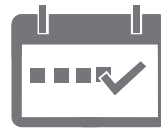




Our visiting rules

Protect yourself and others. In order to keep the risk of infection for patients, employees and visitors as low as possible, the following rules apply:

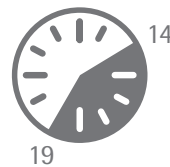
- From the fourth day of inpatient treatment, each patient may receive one visitor a day for one hour.
- Visits are permitted daily between 2 p.m. and 7 p.m.
- Only one visitor is allowed to be in the patient room at a time; this also applies in multiple occupancy rooms. Please coordinate this with your bed neighbour to prevent your visitor from having to wait in the hallway.
- Unauthorised meetings of the patient with other people outside the hospital can lead to isolation measures.
- Hygiene regulations must be observed at all times. Please remember the minimum distance of 1.5 meters, the use of face masks and hand hygiene.



Visiting the sick is allowed after the fourth day



One visitor a day

The visitor needs:

- full vaccination
+ 15 days (with proof) or
- PCR test/antigen rapid
test (< 24 hours) or
- COVID-19 convalescents
(with proof)

Visiting procedure

- On admission, the patient indicates a contact person who is to be given the right to visit.
- At each visit, the visitor has to fill in a questionnaire and have his/her body temperature measured.
- The visitor must have tested negative for coronavirus. Proof: external PCR test or rapid antigen test not older than 24 hours.
- Fully vaccinated people who have had their second vaccination at least 15 days ago do not have to take a test (proof required: e.g., vaccination card, vaccination certificate and photo ID)
- Unvaccinated COVID-19 convalescents can visit patients without a test from day 28 until the end of the 6th month after infection. Proof required: certificate or positive COVID test result.
- Our employees shall verify the data as well as the vaccination or test certificates and will issue a visitor ID with the start time of the visit. According to the Coronavirus Protection Ordinance, hospitals are obliged to record and save the contact details of visitors so that they can be passed on to health authorities in the event of a request.
- Every visitor receives a medical breathing mask from our employees. Using one's own mask is not permitted. Both patient and visitor must wear a face mask during the entire visit.
- When the visitor leaves the hospital, the end of the visit is recorded.

A general ban on visiting
still applies to all patients
with COVID-19 and all suspected
COVID-19
cases as well as patients in
intensive care units.

Please
note!

Patients who are at high risk of infection due to their illness (reverse isolation) may not be visited. Visitors with fever and symptoms of a cold shall not be admitted.

Fathers of newborn babies, relatives of patients in palliative situations and a parent for children and adolescents up to 16 years are excluded from this visitor regulation.

In medically and socially justified exceptional cases, visits can be arranged by contacting the relevant ward by telephone beforehand.

Expectant mothers are allowed to take an accompanying person into the delivery room. It is possible to move into family rooms under certain conditions.

The emergency rooms are open around the clock for all emergencies. Our outpatient clinics are open to patients upon appointment. Patients may only be accompanied by a person in these areas in exceptional cases and after consultation with the treatment team.
